All rental items are to be returned within 2 days, unless otherwise agreed upon. Failure to return items will result in an additional charge to include a daily rental fee. Our rental items are rented out on a Friday and returned the following Monday by 5:00 p.m. All rental items are to returned in the same condition received. Damage to any items will result in an replacement fee (such as wax, burn holes or broken). NO EXCEPTIONS.

Please note that rental items are only secured for your event date with a **25-50% nonrefundable deposit**. All balances must be paid in full prior to the pick-up date of your event. Payments can be made via cash, checks, debit or credit cards. **A 3.65% convenience fee will be charged to all debit/credit cards.** Checks can be accepted up to 2 weeks prior to your event date.

PAYMENT TERMS: Half within 10 days from the date you receive the contract or estimate.

Reservation and Cancellation: You have provied us with an "Estimate" of the type(s) and number(s)of rental items you require. The rented items will be reserved only upon our receipt of the "Reservation Deposit" (or ,if not specified, 50% of the anticipated total Rent). NO REFUNDS if you cancel this contract.

SPECIALITY ORDERS: Deletions or changes must be made with in 30 days before your event date NO EXCEPTIONS....

Set-up and breakdown services can be provided by Memorable Moments for an additional fee. Please note, ALL CHAIRS and TABLES must be BROKEN DOWN and ready for pick up. Additional cost will incur if Memorable Moments has to provide breakdown services. All items for pick up shall remain in the designated delivery area for pick-up by one of our staff members.
